- 1. Welcome and brief report by the Principal about progress report of the Institution during 26-02-2016 to 03.09.2016.
  - > At the outset Principal formally welcomed the Honorable Chairman and all the members of the governing body.

#### Institution report summary:-

- > Detailed admission statistics was placed to the Governing Council for the academic year 2016-17 and as on date 416 students got admitted against 442 intake (94%) for 1 sem BE Programme for the academic year 2016-17.
- > MHRD along with seven Indian Institute of Technologies (IITs) and Indian Institute of Science (IISc) has initiated National Programme on Technology Enhanced Learning (NPTEL). NPTEL Local Chapter is being started in our Institution from the academic year 2016-17. Prof. Vikramaditya.J.M, Assistant Professor, Department of Information Science and Engineering has been nominated as Single Point of Contact (SPOC) and department wise MOOC coordinators have been nominated to coordinate for NPTEL courses in our Institution. As on date more than 300 students and faculty have registered for NPTEL certification courses.
