This has reference to your application I.D. No. **4239-31/10/2019** seeking accreditation by National Board of Accreditation to UG Engineering programs (Tier II) offered by **Sai Vidya Institute of Technology, Rajanukunte, Via Yelahanka, Bangalore Karnataka - 560064.**

2. An Expert Team conducted on-site evaluation of the programs from **19th to 21st March, 2021**. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The competent authority in NBA has approved the following accreditation status to the programs as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted accreditation for 3 years. **Sai Vidya Institute of Technology, Rajanukunte, Via Yelahanka, Bangalore Karnataka - 560064** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Sai Vidya Institute of Technology, Rajanukunte, Via Yelahanka, Bangalore Karnataka - 560064** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
