

SUBJECT-10 Approval for starting the process for NBA Accreditation for MBA Program.

Department of MBA has requested for permission to apply for NBA. The Department has started practicing OBE and Accreditation would bring visibility to the Department.

Resolution: The Members approved to start process for NBA Accreditation for MBA Program.

SUBJECT-11 Approval for the implementation of Career Advancement Scheme (CAS) Policy as per AICTE Norms (Annexure-8).

Principal apprised that a Committee was formed for framing CAS Guidelines and the details has been gathered from AICTE and the Colleges like BMSCE, BMSIT and RVCE and worked out to prepare the draft Policy suiting Sai Vidya Institute of Technology.

This has also been verified by the Administrative Officer (as a part of CAS Committee) and the Board of Directors and it has come out with the opinion that such a Policy is required to safeguard the interest of the long standing employees who are not in a position to get Career Advancement Benefit due to lack of vacancy in the departments. The same has been approved by Board of Trustees.

Chairman expressed that in case such Policies are not made it becomes difficult to retain experienced personnel in the Institution. Therefore, this Policy is necessarily be implemented as soon as possible.

Prof. Y. Jayasimha said that it is also better to increase DA to retain good staff. Chairman also said that there are many people who are working almost since the inception of the Institution. Members also felt that in addition to the CAS Policy increase in DA is also to be done.

Resolution: The Members appreciated the comprehensive Policy – Career Advancement Scheme (CAS) Policy and approved for the implementation with immediate effect.

SUBJECT-12 Approval for the implementation of Industry Consultancy and Sponsored Research (ICSR) Policy (Annexure -9).

Principal said that the Industries are coming to give job and, therefore, ICSR Policy has to be brought into existence. Initially a Committee has been formed to formulate this Policy after consulting Mr Narayana Raju Sir, Founder Trustee and Administrative Officer. It was discussed in two Board Meetings. Board has approved ICSR Policy with additional incentives to be given to those who involve in such activity.

Principal narrated that the people used to negotiate with the Management, bargaining for low Tuition Fees. Therefore, Mr Narayana Raju has suggested that a Policy is formulated in this behalf. According to this Policy, there will be uniformity in fees irrespective of the Authorities with whom the negotiations are made with. There will be no word called concession. Instead, the same will be given in the name of Scholarship and based on this principle the Policy has been brought in.

Principal apprised that the Fees has been fixed as decided by Board and stated in the Policy itself for the Academic Year 2022-23 including for lateral entry students. For those who join Civil and Mechanical Engineering have been given special scholarship in order to encourage the students to join these two branches.

Resolution: The Members appreciated the Admission Policy-2022-23 and approved for the implementation.

SUBJECT-14 Approval for Innovation & Entrepreneurship (I&E) Policy (Annexure – 11)

As per AICTE Norm, I&E Policy was prepared. Member Secretary said that this was prepared by Dr Raghavendra S, HOD-ME, Coordinator NISP/IIIC, under his guidance.
